**WAITING RESTRICTIONS
AND
NO STOPPING AT ANY TIME ON SCHOOL ENTRANCE MARKINGS**

Leeds City Council has made the above Order on the 17th day of August 2007 under the powers contained in the Road Traffic Regulation Act 1984. The effect of the Order which comes into force on the 20th day of August 2007 will be to introduce:-

- 1 no waiting at any time on sections of Butcher Hill, Lea Farm Road and the western access road to Abbey Grange C of E High School;
- 2 no waiting between 8am and 4pm on Monday to Saturday on a section of Butcher Hill (south side);
- 3 no stopping or waiting on the school entrance markings on Butcher Hill (south side).

A copy of the Order together a plan showing the affected sections of highway may be examined during normal office hours at the Legal, Licensing & Registration Reception Desk, 1st Floor, St George House, Great George Street, Leeds 1 and at Ireland Wood Library, 19 Iveson Approach, Leeds 16.

If you wish to question the validity of the Order or any provision contained in it, on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirements of the Act or any Instrument made under the Act has not been complied with in relation to the Order, you may within six weeks from the date upon which the Order was made, apply to the High Court for this purpose.

Leeds City Council in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and in pursuance of powers granted by the Secretary of State under Section 43 and Schedule 3 of the Road Traffic Act 1991 and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

DEFINITIONS

1. For the purposes of this Order:-

"disabled persons badge"	has the same meaning as in Regulation 2 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
"parking disc"	means a valid disc issued by a local authority 125 millimetres square, coloured blue and capable of showing the quarter hour period during which a period of waiting began
"relevant position"	has the same meaning as given in Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000
"universal service provider"	has the same meaning as in the Postal Services Act 2000

WAITING RESTRICTIONS

- 2 Save as provided in Articles 4, 5 and 6 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait in the lengths of road specified in the First Schedule to this Order
- 3 Save as provided in Articles 4, 5 and 6 of this Order no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait between 8 am and 4 pm on Monday to Saturday inclusive in the length of road specified in the Second Schedule to this Order
- 4 Nothing in Articles 2 or 3 of this Order shall prohibit any person from causing or permitting any vehicle to wait in the lengths of road specified therein so long as may be necessary:-
 - 4.1 to enable a person to board or alight from the vehicle
 - 4.2 to enable a vehicle if it cannot be conveniently used for such purpose in any other road to be used in connection with any wedding funeral building operation or demolition the removal of any obstruction in the lengths of road so specified or the laying erection alteration or repair in or near the said lengths of road of any main pipe or apparatus for the supply of gas water or electricity or of any telecommunications apparatus as defined in section 4(3) of the Telecommunications Act 1984
 - 4.3 to enable a vehicle to wait in the said lengths of road if it is a vehicle bearing a livery which is used by a universal service provider engaged in the collection and/or delivery of letters in accordance with statutory duties for the provision of services for the conveyance of letters

- 4.4 to enable a vehicle to be used in the said lengths of road for police ambulance fire brigade local authority sewerage or water undertakers purposes when used in pursuance of statutory powers or duties
 - 4.5 if a vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or for such waiting as is necessary to prevent an accident
 - 4.6 for the purpose of loading or unloading the vehicle while it is in actual use in connection with the delivery or removal of furniture to or from any premises fronting on to the said lengths of road **PROVIDED THAT** notice is given 24 hours in advance to the police and their consent obtained
5. Nothing in Articles 2 or 3 of this Order shall prohibit any person from causing or permitting any vehicle to wait in the lengths of road specified therein for so long as may be necessary to deliver to or collect from or load or unload goods at any premises fronting onto the said lengths of road **PROVIDED THAT** no vehicle so engaged shall wait for longer than 30 minutes outside the same premises without the permission of a police constable in uniform or a traffic warden and provided always that a police constable in uniform or a traffic warden may at any time require the driver of the vehicle to move it if it is reasonably necessary for the purpose of preventing obstruction
6. Nothing in Articles 2 or 3 of this Order shall render it unlawful to cause or permit any vehicle to wait for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road or a part of the same road on the same day) in the lengths of road specified therein if the vehicle displays in the relevant position a disabled persons badge and a parking disc issued by any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England)

Regulations 2000 or a badge having effect under those Regulations as if it were a disabled persons badge and the driver or other persons in charge of the vehicle marks on the said parking disc the time at which the period of waiting began



7. No person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to stop wait or otherwise leave the vehicle in a stationary manner in the length of road specified in the Third Schedule to this Order

GENERAL

8. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the 1984 Act or by or under any other enactment
9. For the avoidance of doubt, any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it
10. This Order is made on the 17th day of August 2007 and shall come into operation on the 20th day of August 2007 and may be cited as the "Leeds City Council (Traffic Regulation) (Waiting Restrictions) (No.W11) Order 2007"

FIRST SCHEDULE

NO WAITING AT ANY TIME

NAME OF ROAD	LENGTH OF ROAD
BUTCHER HILL LEEDS	SOUTH SIDE – From a point 234 meters east of the projected western kerblines of Lee Farm Road in a westerly direction to its junction with Lee Farm Road.
BUTCHER HILL LEEDS	NORTH SIDE – From a point 140 metres east of the projected eastern kerblines of Lee Farm Road in an easterly direction for a distance of 40 metres
LEE FARM ROAD LEEDS	EAST SIDE – From a point 28 metres south of the projected southern kerblines of Butcher Hill in a northerly direction to its junction with Butcher Hill.
ABBEY GRANGE C OF E HIGH SCHOOL WESTERN ACCESS ROAD LEEDS	BOTH SIDES – from a point 7.5 metres north of the projected northern kerblines of Butcher Hill in a southerly direction to its junction with Butcher Hill.

SECOND SCHEDULE

**NO WAITING 8AM TO 4PM
MONDAY TO SATURDAY**

NAME OF ROAD	LENGTH OF ROAD
BUTCHER HILL LEEDS	SOUTH SIDE – From a point 25.5 meters east of the projected eastern kerblines of the Abbey Grange C of E High School Eastern Access Road in an easterly direction for a distance of 52.5 metres.
