**ONE WAY TRAFFIC FLOW**

Leeds City Council in exercise of the powers contained in Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. No person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to proceed in the length of road specified in Column 1 of the First Schedule to this Order in any direction other than that specified in Column 2 of the said First Schedule
2. The Order specified in Column 1 of the Second Schedule to this Order is hereby revoked to the extent specified in Column 2 of the said Second Schedule
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment

4. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it
5. This Order is made on the 31<sup>st</sup> day of October 2008 and shall come into force on the 3<sup>rd</sup> day of November 2008 and shall be cited as the "Leeds City Council (Traffic Regulation) (Movement Restriction) (No.M1) Order 2008"
