**PROHIBITION OF MOTOR VEHICLES
(EXCEPT FOR ACCESS)**

Leeds City Council in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. For the purposes of this Order "**motor vehicle**" has the same meaning as in Section 136 of the 1984 Act
2. No person shall cause or permit any vehicle to enter
 - 2.1 Woodhall Park Drive at its junction with Bradford Road
 - 2.2 Woodhall Park Grove at its junction with Woodhall Lane
 - 2.3 Rockwood Road at its junction with Woodhall Laneother than a vehicle which requires access to any of the lengths of road specified in the Schedule to this Order
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the 1984 Act or by or under any other enactment
4. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it

5. This Order is made on the 15th day of May 2009 and shall come into effect of the 18th day of May 2009 and may be cited as the "Leeds City Council (Traffic Regulation) (Movement Restrictions) (No.M13) Order 2008"
