**PROHIBITION OF PEDESTRIANS
Between 11:00 pm and 07:00 am**

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

As part of the redevelopment of the Market Street Arcade in Leeds it is proposed to close the arcade between the hours of 11:00 pm and 07:00 am.

The Council considers it to be expedient for the arcade to be restricted between the stated hours in the interests of public safety, the preservation of the environment and the protection of property.

During the closure times alternative routes are available via Briggate / Kirkgate / Central Road, or Briggate / Duncan Street / Central Road. Both routes are well lit and are busier providing a greater sense of security to those walking alone.

The owners are intending to provide a high quality environment, but cannot guarantee the safety of pedestrians walking through the arcade late at night. As part of the redevelopment works gates will be provided at either end of the arcade which will be locked and opened at the correct times. Clear and relevant signing will be provided at each end and will be visible at all times.

The closure will allow the environment to be controlled and protected.

**PROHIBITION OF ALL PERSONS BETWEEN
THE HOURS OF 23.00PM AND 07:00AM**

Leeds City Council has made the above Order on 28 May 2010 under the powers contained in the Road Traffic Regulation Act 1984. The effect of the Order which comes into operation on Monday 31 May 2010 will be to prohibit all persons from proceeding in Market Street Arcade off Briggate between the hours of 23.00pm and 07:00am seven days a week.

A copy of the Order together with a plan showing the affected section of highway may be examined during normal office hours at the Legal, Licensing & Registration Reception Desk, 1st Floor, St. George House, Great George Street, Leeds 1.

If you wish to object to question the validity of either Order or any provision contained within it on the ground that it is not within the powers of the Road Traffic Regulation Act 1984, or on the grounds that any requirements of the Act or any instrument made under the Act has not be complied with in relation to the Order, you may within 6 weeks from the date upon which the Order was made, apply to the High Court for this purpose.

PROHIBITION OF ALL PERSONS BETWEEN THE HOURS OF 23.00PM AND 07:00AM

Leeds City Council in exercise of the powers contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. No person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden proceed in the length of road specified in the Schedule to this Order between 23:00pm hours and 07:00am hours seven days a week.
2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the 1984 Act or by or under any other enactment
3. This Order is made on the 28th day of May 2010 and shall come into effect of the 31st day of May 2010 and may be cited as the "Leeds City Council (Traffic Regulation) (Movement Restrictions) (No.M07) Order 2010"
